2. To peruse the Self Study Report (SSR) document for the 4th Cycle of NAAC Accreditation

- A detail and live presentation of the Self Study Report (SSR) for its quantitative matrices and qualitative matrices was made by the IQAC Team. The data and documents were collected by the criteria Coordinators and their team members for a period of over 6 months. Each criteria matrix was perused, and some suggestions were made with respect to verification and revisit of data.
- It was also resolved to properly edit the QLMs regarding language and word counts.
- It was resolved that in case there is need, a request for extension in submission of SSR may be submitted to NAAC.
- Members appreciated efforts of all the Criteria Teams and IQAC.

3. To peruse other quality related matters

 The house perused reports of the Academic Audit of the Schools/Departments and proposed action and action taken and approved the same in principle. However, the Vice Chancellor urged that observations of the Audit Committees may revisited in view of various steps taken by the university with respect to recruitment of teachers and improvement of infrastructure.

• It was also resolved that Academic Audit of the Hamdard Institute of Medical Education and Research (HIMSR) and Jamia Hamdard – Kannur Campus should also be conducted before the NAAC Peer Team visit.
