**Scope of Services provided by the company:**

1. The company will provide minimum three maintenance visit in one year.
2. The walls of the Transgenic Containment Facility must be surfaced with snocem/paint, twice in a year.
3. The parts replaced by the company should be original.
4. Whether a defective item or component is to be replaced or repaired shall be at the sole responsibility of the company
5. Unlimited unscheduled, on call maintenance service should be provided by the company within 24 hours of the complaints.
6. Consumables items i.e. PAR Lights & Candescent Lamps should be covered in this comprehensive maintenance contract.
7. The compressors of the A.C. systems should be covered under the Comprehensive annual Maintenance Contract.
8. The maintenance should be provided on site by the company, which will cover both the spare parts and labour. The replacement of all the spares will be included in the comprehensive maintenance Contract.

The tenure of this comprehensive maintenance contract (CMC) will be of five years, commencing from the date of signing the CMC. The payment of CMC will be on annual basis in two instalments on the satisfactory performance report from the users. However, this contract can be terminated at any time by giving one month notice in writing in advance to either side without assigning any reason.


