At the outset, the Chairman welcomed all the members to the meeting. Then the following agenda item was taken up for discussion:

**Approval of the syllabus of BALLB course:**

- Prof. Furqan Ahmed pointed out that origin & development of Islamic Law must be emphasized. Concepts like 'Hizanat & Guardianship' must be given due importance in the syllabus. Syllabus unit must be made for the concept of guardianship in Family –I syllabus.
- Prof. Furqan Ahmed has further pointed out that the textbooks of Fayzee, Tahir Mahmood, Poonam Pardhan must be incorporated. He stressed upon the further elaboration of Christian & Parsi Laws in Family Law-II.
- Prof. Furqan has taken the syllabus file for further changes.
- Prof. Rizwan Qaiser pointed that 'dialectical relationship of Law society can be incorporated in sociology Unity 3. He further suggested a topic namely 'society & legality' and its evolutionary trajectory.

- All the members of the board of studies unanimously approved the rest of the syllabus.
