ITEM NO. 3 TO START A NEW P.G. PROGRAMME "M.SC.(CS/IT)" FROM THE ACADEMIC SESSION 2019-2020 AS APPROVED BY BOS DATED NOVEMBER 2. 2018.

The item is thoroughly discussed. It is suggested by the members (considering the comment/suggestion by email sent by the Prof. Surendra Prasad) that the nomenclature "M.Sc.(CS/IT)" does not seem to be appropriate since the PG Programmes M.Sc.(CS) and M.Sc.(IT) are supposed to be two different PG programmes with different curriculum. Consequently, the School Board has referred back this agenda item to BOS(CSE) for review.

4(a) TO APPROVE LATERAL ENTRY ADMISSION INTO SECOND YEAR OF MCA PROGRAMME AS PER AICTE NORMS, FOR THE BCA PASSED CANDIDATES.

The 'Admission' is approved as per AICTE norms. However it is further suggested that for the candidates seeking 'lateral entry admission' into the second year of MCA Programme, the admission criteria and other modalities need to be <u>precisely</u> stated by BOS(CSE) in compliance with the AICTE norms. The BOS(CSE) may do this exercise in complete length in its next meeting.

4(b) TO CONSIDER THE "SIX YEARS INTEGRATED BÇA-MCA PROGRAMME" TO BE CONVERTED INTO "FIVE YEARS INTEGRATED BCA-MCA PROGRAMME".
