

AC 33 (13): TO APPROVE THE MINUTES OF THE BOARD OF STUDIES (BoS) HELD ON 5/03/2016 IN THE DEPARTMENT OF ILMUL ADVIA UNDER SCHOOL OF UNANI MEDICINE.

A meeting of the Board of Studies in the Department of Ilmul Advia under School of Unani Medicine was held on 5<sup>th</sup> March 2016 to discuss minor change in the bye laws of CCUD course and consider the panel of examiners for the Department.

The BoS resolved as under:

- As per the existing bye laws of one year Certificate Course in Unani Dispenser, there are four theory and four separate practical / Viva Voce papers in the annual and supplementary examination. For which separate four external examiners were used to be involved. Now it has been recommended in the modified bye laws that only one combined practical / Viva voce examination will be sufficient along with the four theory papers.
- The panel of examiners for the subjects being taught in the Department at UG and PG level were recommended and sent to the Dean for further necessary action.

The above Minutes of the Board of Studies in the Department of Ilmul Advia along with modified bye laws is placed before the Academic Council for kind approval.
