**Item 5: To approve the B. Tech Computer Science & Engineering (Artificial Intelligence) starting from academic session 2020-2021 with an intake of 60 students.**

The BOS approved the course of B. Tech Computer Science & Engineering (Artificial Intelligence) from academic session 2020-2021. With intake of 30 in 1<sup>st</sup> shift and 30 in 2<sup>nd</sup> shift.

**Item 6: To approve two years MCA as per AICTE and in lieu of the same to discontinue the MCA Lateral entry from session 2020-2021.**

The committee approved the two year MCA as per AICTE norms and in lieu of the same to discontinue the three year MCA and two year MCA (Lateral Entry) course.

**Item 7: To reduce the intake in B. Tech (ECE) from 120 to 60 due to less number of admissions and increase the intake in B. Tech (CSE) from 180 to 240. The AICTE has approved last year 60 intake and last 2 year their of no admission than 60 intake.**

Considering lessor number of admissions in B. Tech (ECE), the BOS approves reduction of intake from 120 to 60 and increase in B. Tech (CSE) intake from 180 to 240.

The external member appreciated the achievement of the department.

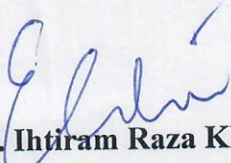

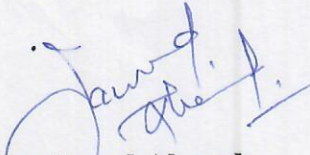

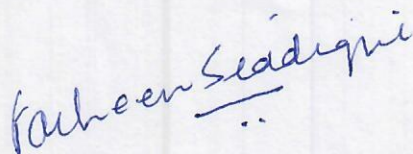
The BOS approved the revised bylaws of Ph. D (CS) & Ph. D (CSE) programs of the department and the same shall be effective from the academic session 2019-2020.

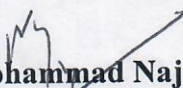

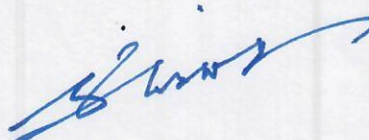
