- Both parties will work together in good faith with the aim of making the event a grand success and each party agrees that, except in the eventuality of gross negligence or flouting of norms by SEST, Jamia Hamdard, New Delhi or its representatives/staff, neither will be liable to the other for any kind of eventuality or loses that are caused due to associated with holding the event.

MEMORANDUM OF UNDERSTANDING

This **Memorandum of Understanding** (hereinafter called as the 'MOU') is entered into on this the 27th day of – February – Two Thousand Nineteen (27.02.2019).

BETWEEN

Department of Computer Science and Engineering, SEST, Jamia Hamdard, New Delhi-110062, the First Party represented herein by Prof M Afshar Alam, Head, Department of CSE, Jamia Hamdard, (hereinafter referred as 'First Party', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

AND

Reaching Sky Foundation, B212, Jawahar Park, Khanpur, New Delhi, 110080, the Second Party, and represented herein by its Director and Founding member Ms Sunidhi Kant, (hereinafter referred to as "**Second Party**", company which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

WHEREAS:

A) First Party is a Higher Educational Institution named:

(i) Department of CSE, SEST, Jamia Hamdard, New Delhi

B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.

D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing

their mutual interest;.

E) **Reaching Sky Foundation, New Delhi**, the Second Party is engaged in Skill Development, Education Improvement and Leadership Building Services in the fields of - *non profitable & social upliftment*

F) Reaching Sky Foundation – ,the Second Party is promoted by Sunidhi Kant, Co-Founder & MD.

G) Founded in September 2015 at Reaching Sky Foundation which is an NGO, They are a kind of team inclusive of students, educators, professionals & changebuilders who advocate the belief that Leaders are made not born because to us leadership is an art that can be mastered as per need & time thus our initiatives attempts to build capacities & leadership skills of children & young people. To accelerate the belief they function on the improvement of quality education, youth empowerment & strengthening of volunteerism. As they realize that being an entity of a rapidly evolving world self-leadership is the key to thrive & become efficient and productive, Thus, they aim to substantially create global citizens so that collectively we all can emerge sustainable lifelong learning & development opportunities.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry, the Second Party.

1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect

to the actions contemplated in terms of this MOU.

The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2 SCOPE OF THE MoU

2.1 The budding graduates from the institutions could play a key role in technological upgradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

2.2 **Curriculum Design:** Second Party will give valuable inputs to the First Party in teaching / training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.

2.3 **Industrial Training & Visits:** Industry and Institution interaction will give an insight into the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the First Party. The industrial training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. The Second Party will provide its Labs / Workshops / Industrial Sites for the hands-on training of the learners enrolled with the First Party.

2.4 **Internships and Placement of Students:** Second Party will actively engage to help the delivery of the Internship and placement of students of the First Party into internships/jobs, as per AICTE internship Policy. The Second Party will also register itself on AICTE Internship Policy Portal for disseminating the Internship opportunities available with them.

2.5 **Skill Development Programs:** Second Party to train the students of First Party on the emerging technologies in order to bridge the skill gap and make them industry ready.

2.6 **Guest Lectures:** Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements.

2.7 Faculty Development Programs: Second Party to train the Faculties of First Party for

imparting industrial exposure/ training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.

2.8 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programs on the terms specified herein

2.9 There is no financial commitment on the part of the both the parties, both parties to take up any program mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

CLAUSE 3 INTELLECTUAL PROPERTY

3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copyrights and designs) of the other Party.

CLAUSE 4 VALIDITY

4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period **Reaching Sky Foundation**, **New Delhi**, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **Training Partner** or, **Reaching Sky Foundation**, **New Delhi** the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU

4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations

CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that **Dept. of CSE, Jamia Hamdard, New Delhi** and **Reaching Sky Foundation, New Delhi** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party.

Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Headquarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of **New Delhi**.

As part of this MoU, both the parties here to agree to the following respectively:

Context

Department of Computer Science & Engineering will instruct the students to apply for training and certifications through **EtrainIndia.** The Department will provide classroom space for conducting events/ programs related to student activities, training, and other student centric activities.

- 6. Would conduct seminars and workshops for students/ faculties to learn about emerging technologies
- 7. Would conduct Faculty Development Programs for faculty members of Jamia Hamdard
- 8. Would also conduct Non-IT programs for students/ faculties such as Entrepreneurship, Digital Marketing and more
- 9. Would offer 4 to 6 weeks online courses (both IT and non-IT) as a part of Summer and Winter Training Program to students of Jamia Hamdard. These courses are offered by world's top colleges and Universities
- 10. Will offer technical support wherever deemed possible to ensure smooth execution of tests

Validity of the Agreement

This MoU will be operational and valid for **five (5) years** from the date of signing or until the date of earlier termination. An understanding between Department of Computer Science & Engineering, Jamia Hamdard and **EtrainIndia** for facilities being provided as mentioned above and the services will be co-terminus with the validity of this MoU.

Upon completion of five years, the MoU can be renewed with mutual consent of both the parties. Either party may terminate this agreement by providing notice of at least thirty days in advance in writing to the other party.
