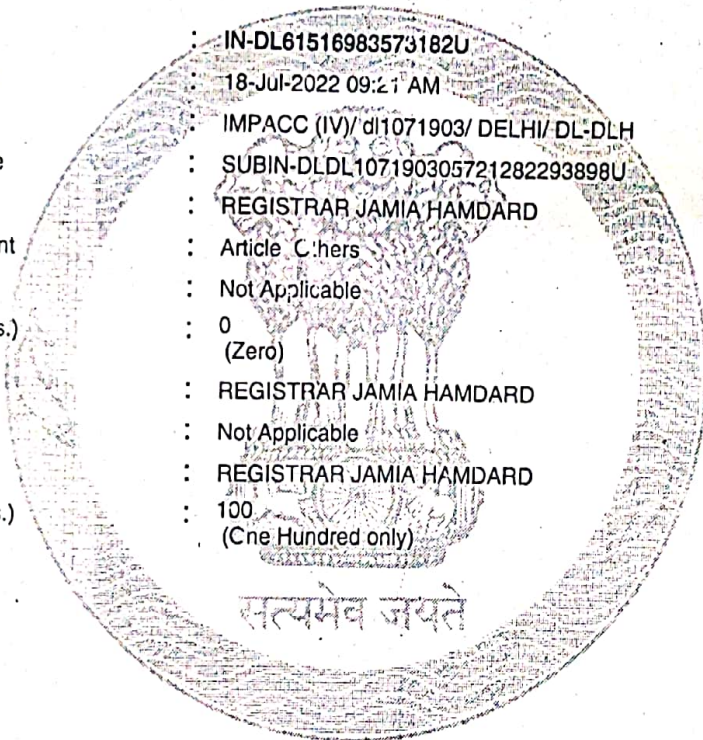

**Jamia Hamdard and Sorditcon Private Limited** are referred to herein individually as a "Party" and collectively as the "Parties".

Now, the parties hereto agree as follows: -

**WHEREAS:**


- 1) The "Sorditcon" will procure the E-waste from "Jamia Hamdard" as per the terms & Conditions agreed in the present agreement.
- 2) The "Sorditcon" will provide all the required documents related to the E-waste management to the "Jamia Hamdard" as per the norms prescribed by the Government Authorities & Pollution Control Board within 60 days of the pickup the E-Waste.
- 3) The "Jamia Hamdard" will sign the required documents to acknowledge that E-waste has been handed over to the "Sorditcon".
- 4) Records & data of the E-waste material procured will be maintained and transparently shared by the "Sorditcon".
- 5) The "Jamia Hamdard" responsibility will cease once electronic waste has been handed over to the "Sorditcon" as per clause 3 above.
- 6) The "Sorditcon" will provide Form 6 and Form 2 document along with the Green Certificate to the "Jamia Hamdard". Based on such




document "Jamia Hamdard" can claim points in NAAC accreditation under the Environmental clause.

- 7) The "Jamia Hamdard" has agreed that the other waste such as Municipal Solid Waste or Hazardous Waste will not be included in the E-waste.
- 8) The "Sorditcon" will conduct E-waste awareness sessions/webinars at Jamia Hamdard Premise as per the agreement between the two parties.
- 9) The "Sorditcon" will install the E-waste Collection bin at the "Jamia Hamdard" premise that in this case Jamia Hamdard premise for the safe collection of the E-waste and then "Sorditcon" team will pick-up such E-waste after reaching certain threshold in weight. The cost of the Bin setup will be borne by the "Jamia Hamdard" only and its cost would be Rs 6,500/- (inclusive of its branding costs).
- 10) The Cost of Logistics for the transportation of the E-waste will be borne by "Sorditcon" only.
- 11) The "Sorditcon" will install the Creative sign boards & small hoardings at the Jamia Hamdard premises to educate students & other people about the E-waste and its proper disposal. The costs of such sign boards will be borne by "Jamia Hamdard".
- 12) The rate of IT & electronics items are shared in the Annexure I in this agreement
- 13) This agreement will be in force for a period of (01year) from the date of execution of this Agreement and as mutually agreed between the parties, may or may not be renewed.
- 14) Either party can terminate this agreement by giving a 30 days written notice in advance to the other party citing grounds for such action. However, the other party is not entitled to claim any compensation for such premature termination, if with reasonable sufficient grounds.
- 15) This Agreement represents the entire understanding between the parties in relation to the subject matter of this Agreement and

supersedes any prior proposal, understanding or agreement either oral or written between the parties in relation to the subject matter here under. Any amendment to this Agreement shall be in writing and signed by both parties.

- 16) This Agreement is governed and interpreted solely by the laws of Indian Administrative Region. Any dispute concerning this Agreement shall be resolved amicably, if not then under the territorial jurisdiction of the courts of New Delhi, India.




