All prospective students seeking admission to the MBBS/MD/MS programmes and/or courses in the Hamdard Institute of Medical Sciences & Research (HIMSR), Jamia Hamdard for the academic year 2024-25 are hereby informed that all admission/course fee shall be deposited strictly in the account of the University namely Jammu & Kashmir Bank, Jamia Hamdard, New Delhi A/c No. 0915040520000004 in favour of Jamia Hamdard, Hamdard Institute of Medical Sciences & Research (HIMSR), IFSC Code: JAKA0JAMIAH, linked with Jamia Hamdard PAN No. AAATJ2432R as per the regulatory requirements of the UGC (Institutions Deemed to be Universities) Regulations. All prospective students applying for these courses/programmes are hereby informed that non-compliance with the aforesaid system of payment and procedure prescribed in the Admission Prospectus issued by Jamia Hamdard (Deemed to be University) will lead to the cancellation of their candidature/application for the aforesaid courses/programmes.

In case of any non-compliance of the stipulations set out in the prospectus related to deposit of fee by the new batch of MBBS/MD/MS in the bank account as mentioned above, by applicants, seeking admission in the Hamdard Institute of Medical Sciences & Research, Jamia Hamdard will neither be allotted an University enrolment number nor they will be allowed to appear at the Examinations conducted by the University for all Degrees awarded by Jamia Hamdard (Deemed to be University) will not be entertained.
