#### UNIVERSITY NOTICE

Sub: Students enrolled in various UG/PG Programmes in Hamdard Institute of Medical Sciences and Research-HIMSR Under Jamia Hamdard, New Delhi - Regarding

It has been brought to the notice to all the medical students enrolled in various UG/PG programmes in Hamdard Institute of Medical Sciences & Research (HIMSR) under the Jamia Hamdard that an illegal Notice dated 31.7.2024 has been issued at the HIMSR level by a suspended employee of HIMSR directing the students to deposit the students' fees into an illegally operated UCO Bank Account having its branch at Talimabad, Gali No.16, Sangam Vihar, New Delhi-110 080 under the PAN of a private party namely Hamdard Education Society.

2. All the students are hereby informed that Jamia Hamdard is a deemed to be University declared by the Govt. of India through Gazette Notification F.No. 9-18/85-U.3 dated 10.5.1989 and it is a degree granting institution for all HIMSR students (MBBS/MD/MS/M.Sc/Ph.D etc.). The Jamia Hamdard, being a deemed to be University is governed by the UGC (Institutions Deemed to be Universities) Regulations as amended from time to time and the relevant statutory provisions of UGC Regulations related to students' fee are reproduced for the benefit of the bonafide students enrolled in HIMSR, JH below: -

## Admission and fees structure. – Fee structure. –

- (1) Donation or capitation fee in whatever nomenclature or form, either directly or indirectly, is strictly prohibited.
- (2) The institutions deemed to be Universities shall follow the rules and regulations regarding fee structure, number of seats, etc., issued by the relevant statutory bodies and in case an institution deemed to be University offers different courses which come under the regulatory ambit of different statutory bodies, namely the University Grants Commission, the All-India Council of Technical Education, National Medical Council etc., the rules and regulations regarding fee structure, number of seats, etc., issued by such statutory body concerned shall be applicable.

(3) The fee shall be fixed transparently, keeping in view non-profiteering or non-commercial aspects.

(4) The fee shall be collected as declared in the prospectus of the institution deemed to be University and with a proper receipt for such payment and the prospectus shall also state that donation or capitation fee

in whatever nomenclature or form, either directly or indirectly, shall not be collected from the student or parent and in case of any grievance, the student or parent may submit their complaint to the institution deemed to be University.

#### XXXX

- (7) Every institution deemed to be University shall maintain the records of the entire process of selection of candidates, exhibit such records on its website, and preserve such records for a minimum period of five years.
- (8) The institution deemed to be University shall make available the prospectus on its website at least sixty days before the commencement of admissions, including fee structure, refund policy, number of seats in a programme, eligibility qualifications, admission process, etc.
- Further, the UGC (Institutions Deemed to be Universities) Regulations related to Funds, Accounts etc. clearly mandates that all the students are required to be deposited ONLY in the University operated/maintained accounts and prohibits depositing in any other private party accounts. In the case of HIMSR, specific directions have been issued by the University Grants Commission not to allow any diversion of students' fee to any other accounts.
- Keeping in view of the statutory obligations on the part of the Jamia Hamdard under the aforesaid UGC Regulations as amended from time to time, the University has published its Admission Prospectus 2024-25 and the copy of the same has been official website available made https://jamiahamdard.edu/uploaded\_files/prospectus.pdf (refer page No.112 to 126).
- Though the University had earlier allowed the students to deposit their course 5. and other fees in the Bank Account No. 0915010100000034 with Jammu and Kashmir Bank, Jamia Hamdard Campus, New Delhi but due to misuse of the said bank account, the approval for fee deposit in the said account has been withdrawn by the University and the subsequently, the said account has been frozen from w.e.f. 5.1.2024.
- Accordingly, on the same day i.e. 5.1.2024 itself, the students of HIMSR were 6. JH/FO/HIMSR/Accts/FC-F.No. Notification through a informed 66/2024/ECOR/07 wherein all students of HIMSR, Jamia Hamdard were categorically asked that henceforth all kind of fees of the students enrolled in various UG/PG/Ph.D programmes in Hamdard Institute of Medical Sciences & Research-HIMSR, Jamia Hamdard shall invariably deposited in the Jamia Hamdard, account No.0387010100001539 IFSC Code JAKAOJAMIAH at J&K Bank, Jamia Hamdard Branch, New Delhi and no deviation shall be allowed in this regard. Copy of the same was also shared in the social medical handle of Jamia Hamdard for the information of students. A copy of the said Notification is available on the University Website for the information of all concerned.

- 7. Subsequently, through a second notification F.No. JH/FO/HIMSR/Accts/FC-66/2024/ECOR/75 dated 6<sup>th</sup> June, 2024, all the UG/PG Medical Students of HIMSR, JH were again duly informed to deposit all the Admission/course fee with the Jamia Hamdard bank account (A/c No. 0915040520000004, Jamia Hamdard, Hamdard Institute of Medical Sciences & Research as per the regulatory requirements of the University Grants Commission as notified through the UGC (Institutions Deemed to be Universities) Regulations through Gazette Notifications, as amended from time to time.
- 8. In the said second notification, it was also informed that -
  - (a) in the case of any non-compliance of deposit of fee by the students of Hamdard Institute of Medical Sciences & Research, Jamia Hamdard neither they will be allotted University enrolment number nor they will be allowed to take University Examinations or awarded Degree from the Jamia Hamdard. Moreover, it was also informed that all the existing students enrolled in HIMSR, Jamia Hamdard were hereby directed to deposit their tuition/course fees of all kind in the Jamia Hamdard HIMSR account as detailed above.
  - b) Students who fail to deposit their fees in the Jamia Hamdard will not be allowed to sit in the University Examinations and consequently, they will not be entitled to get their marks statements and MBBS/MD/MS Degree. - 9. In view of the larger interest of existing and prospective students and their parents studying or to be admitted in UG/PG Medical programmes offered through HIMSR, JH, a Public Notice was issued by the University administration in leading English National dailies viz. The Times of India and The Indian Express (New Delhi/NCR and other city editions) appeared on 13<sup>th</sup> June 2024. In the said notification, it was clearly stated that Jamia Hamdard will not be responsible in case the fees are deposited in any other bank accounts.
- 10. Earlier, some concerns were raised by a section of M.Sc Medical students through their email dated 16<sup>th</sup> July 2024 regarding postponement of their scheduled examinations from 18<sup>th</sup> July 2024. In this regard, it is informed to all such students enrolled in UG/PG Medica/Non-Medical programmes in HIMSR, JH that their fees were not deposited with the Jamia Hamdard bank accounts as directed above. Because of the said reasons and non-adherence of the University directions at HIMSR level, the annual examinations of M.Sc. Medical and M.P.H. has been postponed. It was also notified that the fresh date sheet for the annual examinations for these programmes will be announced only after the student fees are deposited with the University account linked with Jamia Hamdard, New Delhi.
- 11. The Secretary, National Medical Commission, New Delhi as well as the office of the ADG, Ministry of Health and Family Welfare, Govt. of India has been duly

informed about the action taken by the University in this matter through a detailed letter dated 13<sup>th</sup> June 2024 and letter dated 16<sup>th</sup> June 2024.

12. In view of the above statutory provisions all the students of HIMSR, JH are advised not to take cognizance of such illegal notice/communication issued by unauthorized persons. Hence, all the students enrolled for UG/PG/other programmes at Hamdard Institute of Medical Sciences & Research, Jamia Hamdard are hereby advised to take note of the above facts and once again instructed to remit/deposit their course fees to the following University operated account: -

Modi To Skip Ukraine Summit, Return Home From G7

oreign secretary Vinay Kwatra on Wednesday only confirmed a meeting of PM Modi with his Italian counterpart and host Giorgia Meloni, as he said the list of bilateral meetings was still being finalised. A meeting with Trudeau wasn't ruled out.

"The main issue is the political space that Canada provides to anti-India elements that advocate extremism and violence. We have repeatedly conveyed our concerns to them and we expect them to take strong action," Kwatra said, briefing reporters about Modi's G7 visit.

The summit is being held in a luxury resort in the southern region of Puglia. As expected, Modi will skip the peace summit on Ukraine in Switzerland and return straight to India. India will be represented by senior officials at the summit.

Asked about the focus on Russia-Ukraine conflict, Kwatra said India has always maintained that dialogue and diplomacy is the best option. He recalled Modi's remark in Sep 2022 before Russian Presi-

dent Vladimir Putin that "today's era is not of war".

Kwatra spoke about the consequences of the war, including its derivative impact on food, fuel and fertiliser availability, challenges to global supply chains and disruptions in the global economy. "We have always been in the forefront to talk about not just the conflict, the need for dialogue and diplomacy but also the way the conflict is impacting the priorities and interests of developing countries," he said.

"We have always been at the forefront to offer assistance wherever we can to alleviate challenges faced by the Global South because of the conflict, also humanitarian aid to Ukraine," he added.

The foreign secretary said India would continue to share its perspective with world leaders on the sidelines of the summit and continue to emphasise and underline the importance of dialogue and diplomacy to address the situation. According to Kwatra, the G7 summit would also provide a timely opportunity to follow up on outcomes of the G20 summit held under India's presidency last year and deliberate on issues which are significant for the Global South.

REVOKING A month-old order, the Uttar Pradesh government has allowed two subsidiaries of real estate developer M3M India to continue construction work on two commercial plots worth Rs 1,000 crore in Noida.

On May 10, the UP government had cancelled the award of land parcel to Lavish Buildmart Private Limited and Skyline Proposon Private Limited — both M3M group companies — following complaints that the allotment was made to the company at "non-competitive rates".

Now, in a letter to Noida Authority CEO Lokesh M, Anil Kumar Sagar, Principal Secretary of UP Infrastructure and Industrial Development Department, said on Tuesday that after due consideration, a decision has been taken to revoke the cancellation order.

However, the letter did not mention why the government cancelled the allotment in the first place. CEO Lokesh M could not be contacted for comment either.

While cancelling the allot-

ment in May, the department had said that "the aim of any tender is to get a competitive rate, which was not the case here".

Following the cancellation order, Yateesh Wahaal, the director of M3M India, wrote to Nand Gopal Gupta 'Nandi', Minister for Industrial Development and Export Promotion, that it was "completely contrary to the law of natural justice" that the company was not given any chance before taking the decision.

"Lavish and Skyline were not the only successful bidders (in the state) where total number of bidders were less than three. There are other land parcels which have been allotted, where the bidders were less than 3... the auction was done after following all the conditions," said Wahaal in his letter dated May 13.

Speaking on the revocation order, an M3M spokesperson said, "We welcome the decision of the UP government. We are committed to our investment in Uttar Pradesh and will ensure jobs and opportunities, along with creating a masterpiece for the state. This revocation marks a positive step towards restoring confidence among investors and developers..."

The company said that more than 1,400 customers have invested in the scheme and both the firms have together made an investment of Rs 1,500 crore, including payment to the authority.

M3M is developing a project named "M3MThe Line-Retail and Pentsuites" in sector-72 and "M3M The Cullinan Avenue- An Uber-Luxury Mixed use development" in Sector-94. The 3-acre plot in sector-72 was allotted to Skyline Propcon for Rs 176.5 crore in February 2023 while another 13-acre plot was allotted to Lavish Buildmart for Rs 827.3 crore in November 2022.

#### Woman dies after Railway cop husband 'punches' her during fight

New Delhi: A head constable with the Railway Police Force (RPF) has been arrested in Gurgaon's Pataudi for allegedly punching his wife in the face on Monday, leading to her death later at a hospital, the police said.

According to officers, the incident took place on Monday in Haryana's Lokra village after the RPF official, Azad Singh, who was posted in Meerut, had returned home during his leave.

The police have registered an FIR against Azad under section 304 of the IPC at the Pataudi police station on the complaint of his mother, Lali, who stated that Azad had an argument with Asha after he came back home.

The deceased has been identified as Asha, 36. The couple has a son.

"Singh would often fight with his wife and his mother claimed that she saw her daughter-in-law come out of the kitchen with a bleeding face. Later, her health worsened and she was declared dead at the Pataudi civil hospital," an officer said. ENS
